Ron Blatt gave an update on the JMHS baseball field. The Reilley's attorney has requested that the court date be extended from November to February 2019, due to a death in the attorney's family. Judge Hummel will make that decision.

Ron Blatt gave an update on Monarch Stadium. He said they have dealt with much rain and ground water on the site. The foundations are in place for the retaining wall and south ticket booth. The landscape contractor is to be on site next week to start the retaining wall and the mason should be on site to start building the south ticket booth. Field Turf/Basco will be back on site the week of September 17 to continue sidewalks and asphalt for the track area.

Dr. Crook read a statement from our attorney concerning the civil case against the Board of Education et al.

Ron Blatt gave an update on the work being performed by Murray Energy related to Cameron High School. Mr. Blatt said the gas well has been plugged and construction will begin soon on the installation of the air shaft. NGE Firm is under contract to perform geotechnical analysis for the potential athletic fields on the hill behind Cameron High School, but they have not proceeded with that work as of yet.
