Mary Ann Clark and Paula Goldbaugh addressed the Board regarding school reconfiguration (Pre-K to 5) at McNinch Primary and Central Elementary. Information they provided was in regard to extra-curricular activities.

Monarch Stadium

The base mat on the track has been installed and can be used for practice, but the top coat and line striping will occur this spring.

Purchase Order was awarded for the visitor grandstand and the final design is being reviewed and approved.

We will be able to obtain one lane of traffic behind the grandstand when not in use to allow access to field house.

Restroom /concession building – The soils are unsuitable and the contractor will be installing aggregate piers to improve the soil in the next two weeks. This will allow construction to continue, weather permitting.

OWPR is finalizing the design on the locker room facility and will be put out for bid within the next month.

JMHS Auditorium – The majority of work has been completed and a few punch list items remain, but the school is able to use stage and orchestra shell at this time.

MMS – The new secure entrance is nearing completion and the remaining work will be completed over the Christmas break.
