A student discipline hearing for student SDA 22/23-01 was conducted.

Assistant Principal Geno Polsinelli presented the case.

David Soltesz, Personnel Director, acted as Hearing Officer.

Present were parent and student. The parent requested an open hearing.

Superintendent's Report

Marshall County Schools received a letter of gratitude from the Knights of Columbus for supporting the Irish Road Bowling event. One of the projects that the KOC provides is Coats for Kids, in which they purchased 96 coats for local children this holiday season.

Mr. Soltesz has been working on recruiting, training and hiring professional and service substitutes. During the last set of postings, there were 22 applicants to become a substitute aide, 12 of whom showed up to be tested, 9 of whom passed. In the category of secretary, there were 35 applicants, 12 showed up to be tested, and 7 passed the state test. In the area of cooks, 25 applied, 12 showed up to be tested, and 2 passed the test. In the category of custodian, 13 applied, 5 showed up to be tested, and 3 passed.

This weekend John Marshall High School will host "The Nutcracker" in the CPA. Elementary students will attend this week during the day. Also, on the November 29th the Marshall County Strings will hold a concert and Monarch Tidings will be Thursday, December 8th.
